1. Expenditure under S137 Local Government Act 1972 and S2 Local Government Act 2000

Section 137(1) of the 1972 Act permits the Council to spend on activities for which it has no other specific powers if the Council considers that the expenditure is in the interests of, and will bring direct benefit to, the area or any part of it, or all or some of its inhabitants, providing that the benefit is commensurate with the expenditure. Section 137(3) also permits the Council to incur expenditure for certain charitable and other purposes. The maximum expenditure that can be incurred under both section 137(1) and (3) for the financial year 2022-23 was £8.82 per elector.

In 2022-23, the Council made payments totalling £ 100.00 under section 137. These payments are included within 'Other payments' in the Accounting Statement.

I certify that I have completed the audit of the Annual Return for the year ended 31 March 2023 of **Brynmawr Town Council**. My audit has been conducted on behalf of the Auditor General for Wales and in accordance with the requirements of the Public Audit (Wales) Act 2004 (the 2004 Act) and guidance issued by the Auditor General for Wales.

Audit opinion: Unqualified

On the basis of my audit, in my opinion no matters have come to my attention to give cause for concern that, in any material respect, the information reported in this Annual Return:

- has not been prepared in accordance with proper practices;
- that relevant legislative and regulatory requirements have not been met;
- is not consistent with the Council's governance arrangements; and
- that the Council does not have proper arrangements in place to secure economy, efficiency and effectiveness in its use of resources.

Council minutes


As part of our audit process, we reviewed the council minutes held on its website. Our audit identified that these were incomplete. We recommend that the Council reviews the minutes published on its website to ensure they include all council meetings.

Arithmetic error in Accounting Statement

There is a £1 rounding difference between the reported closing balance at 31 March 2022 (line 7 2021-22 comparative accounts) and the balance brought forward at 1 April 2022 (line 1 of 2022-23 accounts).

We recommend that the Council checks the consistency and arithmetic accuracy of the accounts before approval.
